## TERMS AND CONDITIONS OF THE TENDER FOR DISPOSAL OF OLD <u>VEHICLES</u>

- 1. The vehicle is stationed at OSSC Ltd Campus as mentioned in the Tender notification and can be inspected from 26.06.2024 between 11.00 A.M. to 3.00 P.M. The bidders are requested to contact the Company Secretary, OSSC Ltd. to visit the sites where the vehicles are stationed.
- 2. Bid forms along with tender documents can be downloaded from OSSC Ltd. website from the Managing Director, Odisha State Seeds Corporation Ltd., on payment of Rs.400 + GST 12% = Rs. 448/- (Rupees four hundred forty eight only), through a Demand Draft drawn in favour of the Managing Director, Odisha State Seeds Corporation Ltd., Bhubaneswar from 26.06.2024 to 11.07.2024 between 11.00 A.M. to 3.00 P.M. in that case, the Demand Draft towards cost of application should be enclosed to the Tender bid.
- 3. The tenders should be accompanied with the prescribed EMD of Rs. 9,000/-(Rupees nine thousand only) in the form of Demand Draft drawn in favor of the Managing Director, Odisha State Seeds Corporation Ltd., Santrapur, Bhubaneswar. Tender Bids without EMD will be summarily rejected.
- 4. The sealed tender bids should be submitted at the office of the Odisha State Seeds Corporation Ltd., Santrapur, Bhubaneswar on or before 11.07.2024 by 5.30 P.M. The Tenders will be opened on 12.07.2024 at 11.00 AM.

Vehicle will be allotted to the successful highest bidder against full payment of the bid price through a Demand Draft drawn in favor of Odisha State Seeds Corporation Ltd., Santrapur, Bhubaneswar, which should be arranged within three (03) working days from the date of opening of the tenders and allotment of vehicle.
- 6. The delivery of the sold vehicle will be given only after the successful bidder submits vehicle cost DD and documentary evidence in support of residential status (Ration Card/ Voter Identity Card in case of individual and Registration Certificates in case of firms etc). The sold vehicle shall have to be removed by the successful bidder immediately at his own expenses. The vehicle will be disposed off on "as is where is basis" and no guarantee for its worthiness or quality will be given by this office.

- 7. The successful bidder will also be responsible for getting the Registration certificate of the vehicle transferred in his name at his own cost expeditiously. This office is not responsible for any lapse on his part in this regard.
