

- 5- Candidate serving in Government, Quasi Government Offices/Public Sector Undertakings (including Nationalised Bank and Financial Institution) are required to produce a 'No objection Certificate " from their employer at the time of certificate verification in advance of which candidature will not be considered.
- 6- Experience Certificate in support of experience mentioned in the registered application forms on the date of submission of submission of application.
- 7- The candidate's photo identity such as Voter Card/Adhar Card/Driving License/Passport with photograph should be brought in original for verification.
