1. Manufacturing of Sieves with adequate frames made out of suitable IS members, perforated sheet made out of **0.80mm** thick MS plates with perforation of size as indicated below with solid sheet border on all edges, which then be welded to MS frame to form the complete Sieve. The complete Sieve to be finished with due grinding and painting.

2. The complete set for each Seed Processing Plant to be packed duly and be transported to the location of the processing plant. The packing, forwarding, transporting along-with the delivery to the processing plant will be responsibility of the selected firm through this EOI.

3. The selected firm shall depute personnel to the location of the processing plant for fixing of the set of sieves in the Precleaner/ Grader of the processing plant. Any readjustment required for proper fitting of the Sieve in the Processing Plant will be done by the supplier. After the above process the supply will be treated a complete.

## **B. Supply Period**

The selected Firm shall be required to supply all the Sieves within 60 days from the date of issue of work order.

## **C. Submission of EOI Document**

Interested Firms/ Agencies are requested to read the document careful before submission of their offer.

The Firms/ Agencies should submit the following along with filled up and signed & stamped EOI document

2. The participating firm should submit the copy of the GST Registration Certificate.
3. The participating firm should submit the copy of the PAN Card.
4. The applicant should be a manufacturing company registered under the Companies Act-1956/ 2013 or a Partnership Firm registered under partnership act 1932, Sole Proprietorship or Government owned entity. (Self attested copies of the registration certificate has to be submitted along-with the document.)
5. Having experience of satisfactory execution of at-least one single purchase order in last 2 years
6. Participating firm shall sign each page of the EOI document in acceptance of the terms and conditions of the tender schedule.

#### **D. Acceptance of Terms & Conditions & Security Deposit**

The selected Firm shall be issued with detailed work order and the firm will return a signed and stamped copy of the same to this office as a token of acceptance of the terms and condition under which the supply will be made

The firm shall deposit 10% of the value of the supply (without taxes) as Security Deposit which the firm shall deposit in the Bank Account of OSSC Ltd detailed of which has been mentioned in this document above.

#### **E. Penalty**

In the event, the firm fails to complete the job within stipulated period 0.5% of total value of order (without taxes) for delay of one week or part thereof and will accumulate so on till it reaches 10% will be deducted from the Security Deposit made by the firm with OSSC or from the payables to the firm.

#### **F. Warranty**

The firm that will be selected for supply the material shall provide warranty on durability of the Sieves supplied under normal use for a period of one year from the date of receipt of the same at desired location.

On detection of the same the firm shall repair the defects at the location of the supply promptly.

#### **G. Rate**

The firm shall quote rate after verifying the Sieves required at these places and it will also be the responsibility of the intending firm to determine exact dimension of the sieve. The intending firm also take into consideration the distance to be covered for delivery and other related aspect to arrive in the final quoted price.

It will be presumed that the intending firm has checked all parameters connected with the supply of the Sieves and no further cost will be entertained connected with the completion of supply.

The intended supplier shall price of components as mentioned below including all taxes and duties.

#### **H. Payment**

Payment will be made after completion of the supply and receipt of the bills after entering them to stock from each location along-with certificate of satisfactory completion of supply.

Payment will be released after observing due procedure which is expected to be within 45 days as such.

## **I. Settlement of Dispute**

Any difference or dispute arising out of this supply shall be decided amicably and in the event of dispute the Hon'ble Court at Bhubaneswar shall have the sole jurisdiction to decide the same.

In any event no cause of action shall arise in the favor of either party to approach any other Court, than the Hon'ble Courts at Bhubaneswar.
